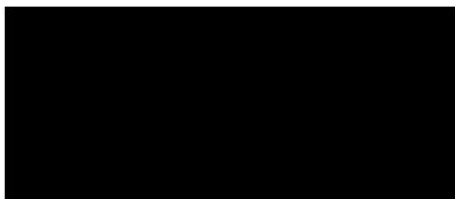
Thank you for your official information request dated Thursday 11 January 2024.
