I appreciate WWL's response.

However, I need some clarification so I'm clear about the scope of the existing consents and also the scope of existing activities that are not consented.

I'm somewhat confused about your reference to WWL currently developing an application for a global wastewater discharge consent.

What exactly does that mean? In simple terms is that:

- an acknowledgement by WWL that it is currently operating without the necessary consents with respect to discharge of wastewater to the coastal marine area and/or to freshwater watercourses
- a process divorced from WWL's endeavours to renew its existing discharge to stormwater consent WGN180027
- and if so does that mean the WWL is actively working towards yet another standalone consent – this time a global wastewater consent.

My understanding is as follows:

- a. WWL/PCC has previously been issued discharge consents (air and water) for the operation of the WWTP.
- b. WWL is claiming this is a 'roll-over' consent on the basis that s.124 of the RMA applies.
- c. WWL agrees that this 'roll-over' consent does not (and will not if it is granted) encompass discharges of untreated wastewater directly to the CMA when the Rukutane Point pumpstation capacity is exceeded.
- d. WWL has an existing stormwater network consent WGN180027.
- e. This consent allows certain discharges of wastewater to the stormwater network.
- f. WWL does not have a coastal permit allowing it to discharge wastewater directly to the CMA when the capacity of the Rukutane Point pumpstation (135L/s) is exceeded.
- g. WWL agrees its existing network discharge consent (WGN180027) does not apply to the Rukutane Point pumpstation 'overflow' discharge.
- h. WWL agrees that all discharges from the Rukutane Pt pumpstation (which, by definition, do

not include discharges from the WWTP) are unlawful.

- i. WWL agrees there are other unlawful discharge points located within Porirua City.
- j. Those other unlawful discharge points are where the overflow wastewater discharges directly to the wider environment, and not to the stormwater network, and are therefore not encompassed by the 'global' consent WGN180027.

If any aspect of 'my understanding' above is incorrect please let me know, which and why.

If I am correct in my understanding, please confirm.

As you will be aware, the Wastewater Treatment Plant and Landfill Joint Committee meets on 30 August 2022. It is urgent that the Committee is provided with accurate information, and I therefore request the information I've sought by 5pm tomorrow (29/08/2022).

I write in response to your formal complaint dated 8 August 2022.

Your complaint is in relation to the unauthorised discharges of untreated wastewater from the Rukutane Wastewater Pumping Station to the coastal marine area. I understand that your complaint specifically relates to the absence of a coastal permit for continuing discharges from this location.

We do not materially disagree with the statement of facts you have provided and agree that the current situation is not acceptable. This response will provide some further context and outline Wellington Water's approach to remedying the lack of coastal permit for this discharge.

Rukutane Point is one of many unauthorised discharge points located within Porirua City. In essence, the wastewater network (pipes and pump stations) has finite capacity and is prone to inflow and infiltration from rainfall. While the network is designed to carry some rainfall, in larger wet weather events its capacity can be exceeded. To respond to this (and avoid wastewater coming up toilets in houses, etc) deliberate overflow points were incorporated into the system. Historically these overflows were considered to be emergency discharges by those managing the wastewater networks and resource consent for direct and indirect discharges from the network had not been sought.

Wellington Water as managers of the wastewater network are clear that consent is required and that overflows must be reduced as much as practicable. In addition, the community has made it clear that wastewater network overflows are occurring much too frequently. To address these issues we are working on 'global' wastewater network overflow consents, across the various wastewater catchments. We have been working on the consent application for a number of years and have

engaged with Porirua City Council, Te Runanga o Toa Rangitira as well as harbour and community groups in its development. The global consent application for Porirua is expected to be lodged sometime in March 2023, and overflows from the Rukutane pump stations will be part of that application. The application proposes a framework for reducing the frequency and volume of wastewater network discharges over the life of the consent.

I hope that this explanation can provide you with some comfort that your concerns are shared and that Wellington Water and Porirua City Council are working to remedy the situation.
