Private water leak – First Notice to Fix 305 Waiwhetu Road, Fairfield , Lower Hutt, 5011

Dear Milton Court Ltd

As part of Wellington Water's water conservation and leak detection activities, we have identified a water leak on the private service at your property during a leak detection survey.

It's important for water leaks to be fixed as soon as possible to minimise wastage and reduce the risk of damage to your property.

Our investigations suggest that the private water leak is beyond the Council point of supply and within your property. Please arrange for a plumber to investigate and fix the leak by 25 September, 2023

Under the **Hutt City Council's** water supply bylaw, the property owner is responsible for maintaining their water service pipe and fittings from the point of supply (toby) into their property. Under Section 192 of the Local Government Act (2002), wasting water is not permitted and the supply of water may be restricted under Section 193 if the building owner fails to act on this notice.

Please arrange for your plumber to investigate and repair the leak. If you don't have one, a certified plumber can be found on the Master Plumbers website by visiting the following link: www.masterplumbers.org.nz/homeowner-info

If you are a tenant at this address, please call us as soon as possible and advise us who the property owner is so we can work with them to ensure the water leak is fixed.

Once the leak is repaired, please call Wellington Water on 04 912 4470 or mail <u>privateleaks@wellingtonwater.co.nz</u> to let us know the work has been completed.

If you have any questions or concerns about what is expected, please let us know.
